General Terms and Conditions for Photographic License

Following General Terms and Conditions are applicable for all orders, deliveries and services provided by the photographer. The same are applicable for each stage of creative development and in particular for digitally produced photographs;

1. Within the context of an ongoing business relationship, the General Terms and Conditions are applicable, even without explicit approval, to all future orders, quotes, deliveries or services of the photographer.
2. That this license is for single person for photography in the premises of Quaid-i-Azam Mazar & Bagh-e-Quaid-i-Azam
3. That this license is neither transferable nor sub-licensing to third party.
4. That this license is valid for still photography only.
5. That the licensee will submit pay order of **Rs. 2000/-** (Rupees: Two Thousand Only) as security deposit in advance in favor of Resident Engineer QMMB, Karachi.
6. That the licensee will submit pay order of **Rs. 1000/-** (Rupees: One Thousand Only) per month drawn in favor of Resident Engineer QMMB, Karachi by the 05th of each calendar month failing which late payment surcharge of **Rs. 200/-** (Rupees: Two Hundred Only) will be imposed. In case of non-payment of prescribed fee consequently for the period of two month, the license will be cancelled at the risk and cost of licensee and the security deposit will be forfeited.
7. That no photography is allowed without the consent of visitor/guest/ celebrity or anything into the Mazar.
8. That all the photographers are bound to inform the visitor about the photographic charges prior the photography i.e. **Rs. 60/-** (Rupees: Sixty only) for eight photographs (without printing) and **Rs. 70/-** (Rupees: Seventy only) for a single Polaroid or printed photograph.
9. That the licensee is required of having cameras and other equipment like printers etc necessary for carrying out the orders.
10. That the licensee will observe sanctity of Mazar and will behave politely with the visitors of Bagh-e-Quaid-i-Azam and Quaid-i-Azam Mazar.
11. That the licensee shall save all the Photographic images drawn during last 15 days and shall be bound to provide the same to this office, if needed.
12. That the licensee will be responsible for complaints regarding the content, quality or condition of the photographic images within 08 days of receipt of photographic images by visitor/guest/ celebrity or any other else.
13. That the licensee is responsible for ensuring that persons, objects and locations for carrying out the orders are available and are accessible.
14. That in case of any dispute with the visitor or with other licensee or with the employee of Quaid-i-Azam Mazar or with any other person relating to Mazar, the licensee is responsible to report the matter to the control room of Quaid-i-Azam Mazar during the office hours and to Resident Engineer or nominated Officer during office hours for settlement of issue.
15. That this licensee is subject to the wearing of approved uniform i.e. sky blue color trouser & shirt, dark blue color cap with white monogram of Mazar, black shoes with black shoe cover, black belt except Friday. On Friday all the photographers shall wear pure white Shalwar Kamees and white Muslim cap on head. The licensee can wear dark blue color cap with white monogram of Mazar on Friday also.
16. That the licensee will not be allowed to stand into main mausoleum building, upper/lower podium and into the flowering troughs.
17. That the photographer will attend the visitor in a good manner and shall speak politely.
18. That no any photographer will compel any visitor/guest/ celebrity or any other for photography.
19. That smoking of cigarette/ spitting of pan, naswar, chewing gum, chalia etc. is prohibited at mausoleum.
20. That in case of default/ breach of any of the above condition, fine of up to **Rs. 1000/-** will be imposed on violator.
21. That in case of default/breach of any of the above condition for three times, the license shall be cancelled without any prior notice and at the risk and cost of the licensee and the security deposit of amounting **Rs. 2000/-** will be forfeited.
22. That the license will renewed at the end of each year subject to observance of terms and conditions of license by the licensee.
